

# Teton County 4-H Horse Show Expectations

- We recommend that your 4-H horse is immunized. If your horse is exhibiting signs of illness at any 4-H horse function, you may be asked to remove your horse from the grounds. **Please do not bring a sick animal to the fair.**
- Bareback classes will be judged by following levels: Walk-Trot, Levels 2-3, Levels 4-7. Members may enter only one class -- either at level or walk-trot, regardless of age of member.
- Trail classes will be judged by following levels: Walk-Trot, Levels 2-3, Levels 4-7. Members may enter only one class -- either at level or walk-trot, regardless of age of member.
- All 4-H horse members are required to interview with a judge at the Pavilion on Wednesday of the Teton County 4-H Fair.

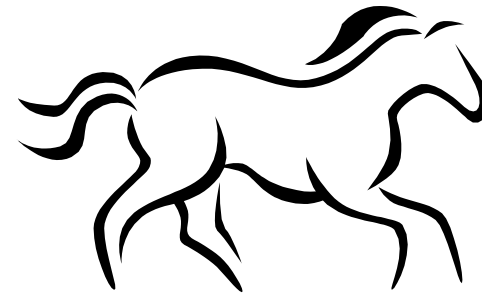

# Teton County 4-H Horse Program

- The Teton County 4-H horse members are expected to follow the Montana State 4-H Horse Show **Dress Code** and **Judging Criteria**. Copies of these are available on the Teton County Extension website.
- The schedule for the horse show is in the fair book.
- **Horse project members must be assessed by a certified leader by the Horse Showcase deadline.** The horse committee reserves the right to adjust fair entries and enrollment levels.
- As a courtesy to others, please **do not bring a sick horse** to any 4-H horse activity.
- There will be a designated warm up area at the Teton County 4-H Horse Show. Horses must be walked in all areas other than warm up areas.

## Teton County 4-H Horse Show Expectations

- Levels 1-3 4-H horse members in Teton County will be allowed to ride their project horse regardless of the horses age, using two hands with any non-leverage bit.
- Teton County 4-H horse members need to be assessed every year by June 11 in order to participate in the 4-H horse show at the Teton County 4-H Fair.
- The 4-H member must use their own project horse in showmanship classes.
- Teton County 4-H horse members must be working in Level 3 in order to participate in optional horse projects.
- All horses must be ridden using appropriate riding equipment.
- Any county horse leader can assess any member, provided it is not their own child. First year 4-H horse leaders need to have an experienced or key leader in the horse area assist them while doing assessments.
- Any 4-H horse member or horse needing special consideration, must submit their request in writing by the day before the Teton County Horse Show. Consideration will be reviewed by the member's 4-H horse leader and project key leader and extension agent. No changes will be considered on the day of the show.
- Not all classes available in the State 4-H Show guidelines will be available at the Teton County 4-H Fair.
